Decision giving consent to the appointment of the Commission

---

PURPOSE: to appoint the European Commission for the period from 10 February 2010 to 31 October 2014.

LEGISLATIVE ACT: Decision of the European Council 2010/80/EU appointing the European Commission.

CONTENT: by means of a vote held on 9 February 2010, the European Parliament gave its approval to the appointment of the President, the High Representative of the Union for Foreign Affairs and Security Policy and the other Members of the Commission as a college. Accordingly, this Decision appoints the members of the European Commission for the period from 10 February 2010 to 31 October 2014. The following persons are appointed:

The European Parliament gave its consent by 448 votes to 137, with 72 abstentions, to the appointment of the President, the Vice-President for External Relations (High Representative of the Union for Foreign Affairs and Security Policy) and the other Members of the Commission, as a body, for the term of office running to 31 October 2014.
