The European Parliament adopted by 561 votes to 13 with 50 abstentions a decision delivering a favourable opinion on the nomination of Kersti Kaljulaid (EE) as a Member of the Court of Auditors.

PURPOSE: to appoint a member of the Court of Auditors.

LEGISLATIVE ACT: Council Decision 2010/246/EU appointing nine members of the Court of Auditors.

CONTENT: under this Decision, Ms Kersti KALJULAIID is appointed member of the Court of Auditors for the period from 7 May 2010 to 6 May 2016.
