LEGISLATIVE ACT: Council Decision 2010/246/EU appointing nine members of the Court of Auditors.

CONTENT: under this Decision, Mr Louis GALEA is appointed member of the Court of Auditors for the period from 7 May 2010 to 6 May 2016.
