The Committee on Budgetary Control adopted the report drafted by Inés AYALA SENDER (S&D, ES) in which it calls in the European Parliament to deliver a favourable opinion on the nomination of Harald Wögerbauer (AT) as a Member of the Court of Auditors.

The European Parliament adopted the appointment of Harald Wögerbauer as a Member of the Court of Auditors in a secret ballot by 409 votes to, 33 against and 219 abstentions.

PURPOSE: appointment of the Austrian member of the Court of Auditors.

NON-LEGISLATIVE ACT: Council Decision 2011/183/EU appointing a member of the Court of Auditors.

CONTENT: following the resignation on 1 January 2011 of Mr Hubert WEBER from the position as member of the Court of Auditors, the Council decided to appoint Mr Harald WÖGERBAUER as member of the Court of Auditors for the remainder of the term of office to run, i.e. from 1 April 2011 to 31 December 2013.

ENTRY INTO FORCE: 21 March 2011.
