The Committee on Budgetary Control adopted the report drafted by Inés AYALA SENDER (S&D, ES) in which it calls on the European Parliament to deliver a favourable opinion on the nomination of H.G. Wessberg (SE) as a Member of the Court of Auditors.

The European Parliament adopted by 391 votes to 65, with 94 abstentions, in a secret ballot, a decision approving the nomination of H.G. Wessberg (SE) as a Member of the Court of Auditors.

NON-LEGISLATIVE ACT: Council Decision 2011/373/EU appointing a member of the Court of Auditors.

CONTENT: following the resignation of Mr Lars HEIKENSTEN, member of the Court of Auditors, on the 15 May 2011, the Council has decided to appoint Mr H. G. WESSBERG as a member of the Court of Auditors for the remainder of the term of office of Mr Lars HEIKENSTEN, which runs until 29 February 2012.
