Court of Auditors: appointment of a member, H.G. Wessberg - SE

The Committee on Budgetary Control adopted the report drafted by Inés AYALA SENDER (S&D, ES) in which it calls on the European Parliament to deliver a favourable opinion on the Council's nomination of Hans Gustaf Wessberg (SE) as a Member of the Court of Auditors. Hans Gustaf Wessberg fulfils the conditions laid down in Article 286(1) of the Treaty on the Functioning of the EU (TFEU).

The European Parliament adopted by 606 votes to 39, with 55 abstentions, a decision in which it delivers a favourable opinion on the Council's nomination of Hans Gustaf Wessberg (SE) as a Member of the Court of Auditors.
