Court of Auditors: appointment of a member, Vítor Caldeira - PT

The Committee on Budgetary Control adopted the report drafted by Inés AYALA SENDER (S&D, ES) in which it calls on the European Parliament to deliver a favourable opinion on the Council's nomination of Vítor Manuel da Silva Caldeira (PT) as a Member of the Court of Auditors. Vítor Manuel da Silva Caldeira fulfils the conditions laid down in Article 286(1) of the Treaty on the Functioning of the EU (TFEU).

The European Parliament adopted by 622 votes to 36, with 32 abstentions, a decision in which it delivers a favourable opinion on the Council's nomination of Vítor Manuel da Silva Caldeira (PT) as a Member of the Court of Auditors.
