The Committee on Budgetary Control adopted the report drafted by Inés AYALA SENDER (S&D, ES) in which it calls on the European Parliament to deliver a favourable opinion on the Council's nomination of Ville Itälä (FI) as a Member of the Court of Auditors. Ville Itälä fulfils the conditions laid down in Article 286(1) of the Treaty on the Functioning of the EU (TFEU).

The European Parliament adopted by 625 votes to 41, with 29 abstentions, a decision in which it delivers a favourable opinion on the Council's nomination of Ville Itälä (FI) as a Member of the Court of Auditors.
