Court of Auditors: appointment of a member, Kevin Cardiff - IE

The Committee on Budgetary Control adopted the report drafted by Inés AYALA SENDER (S&D, ES) in which it calls on the European Parliament to deliver a favourable opinion on the Council's nomination of Kevin Cardiff (IE) as a Member of the Court of Auditors. Kevin Cardiff fulfils the conditions laid down in Article 286(1) of the Treaty on the Functioning of the EU (TFEU).

The European Parliament adopted by 521 votes to 128, with 34 abstentions, a decision in which it delivers a favourable opinion on the Council's nomination of Kevin Cardiff (IE) as a Member of the Court of Auditors.
