Court of Auditors: appointment of a member, Iliana Ivanova - BG

The Committee on Budgetary Control adopted the report by Inés AYALA SENDER (S&D, ES) in which it calls on the European Parliament to deliver a favourable opinion on the Councils nomination of Iliana Ivanova as a Member of the Court of Auditors.

Parliament's Committee on Budgetary Control evaluated the credentials of the nominee and considered that the candidate fulfilled the necessary requirements laid down in Article 286(1) of the Treaty on the Functioning of the European Union.

The European Parliament adopted by 309 votes to 39, with 185 abstentions, a decision in which it delivers a favourable opinion on the Councils nomination of Iliana Ivanova as a Member of the Court of Auditors.

NON-LEGISLATIVE ACT: Council Decision 2012/402/EU appointing a member of the Court of Auditors.

CONTENT: the term of office of Ms Nadejda SANDOLOVA is due to expire on 31 December 2012. The Council has decided to appoint Ms Iliana IVANOVA as member of the Court of Auditors for the period from 1 January 2013 to 31 December 2018.
