## Amendment of the Financial Regulation of 21.12.1977 applicable to EC budget: budgetary discipline

The proposal for a technical regulation was aimed at including in the financial regulation of 21 December 1977 the amendments provided for in the draft for a new decision on budgetary discipline (creation of a reserve to guarantee loans issued by the Community to non-member countries together with a reserve for emergency aid) and the proposed setting-up of a guarantee fund, by way of an appropriate response to the amendments made to the Maastricht Treaty. This had implications on two levels as far as the Financial Regulation was concerned: - recognition of the new reserves and the procedure to be used for their mobilisation; - the link between the general budget and the guarantee fund. ?

## Amendment of the Financial Regulation of 21.12.1977 applicable to EC budget: budgetary discipline

The Committee adopted two reports by Mr Zavvos on the amendment of the Financial Regulation, calling in particular for the inclusion in the budget of borrowings and loans and a systematic utilisation of the ecu and raising the issue of the expenditure of the Committee of the Regions and the Ombudsman and the personnel policy of the European Institutions. ?

## Amendment of the Financial Regulation of 21.12.1977 applicable to EC budget: budgetary discipline

The European Parliament tabled amendments seeking to introduce a reference to the Interinstitutional Agreement of 28 October 1993 which provided for the creation of a Guarantee Fund within the framework of the Community budget for loans to third States, to provide, as far as revenue was concerned, for a host structure for the various sources of endowment of the Fund, and to create, as far as expenditure was concerned, budget headings corresponding to lines created in the revenue section, and to provide for a synoptic table setting out all the operations carried out by the Fund. In addition, the European Parliament reserved the right to call for the conciliation procedure to be opened should the Council intend to depart from the text approved by Parliament. ?
