2014/0222(NLE) - 23/07/2014 Initial legislative proposal

PURPOSE: to conclude, on behalf of the European Union and its Member States, the Accession Protocol to the Framework Agreement on Comprehensive Partnership and Cooperation between the European Community and its Member States, of the one part, and Viet Nam, of the other part, to take account of the accession of Croatia to the European Union.

PROPOSED ACT: Council Decision.

ROLE OF THE EUROPEAN PARLIAMENT: Council may adopt the act only if Parliament has given its consent to the act.

BACKGROUND: according to its Act of Accession, Croatia undertakes to accede to the international agreements signed or concluded by the European Union and its Member States by means of a protocol to those agreements.

The Framework Agreement on Comprehensive Partnership and Cooperation between the European Union and its Member States, of the one part, and Viet Nam, of the other part, was signed in Brussels on 27 June 2012.

The Agreement is currently undergoing ratification and has not yet entered into force.

Following a Council Decision on the signing, on behalf of the European Union and its Member States, of the Protocol to the Framework Agreement on Comprehensive Partnership and Cooperation between the European Union and its Member States, of the one part, and Viet Nam, of the other part, to take account of the accession of Croatia to the European Union, the Protocol was signed.

It is now necessary to approve the Protocol on behalf of the Union and its Member States.

CONTENT: under this proposal, the Council is called upon to adopt a decision aiming to approve the Accession Protocol to the Framework Agreement on Comprehensive Partnership and Cooperation between the European Community and its Member States, of the one part, and Viet Nam, of the other part, to take account of the accession of Croatia to the European Union on behalf of the

European Union and its Member States.

The proposed Protocol incorporates Croatia as contracting party to the Agreement and commits the EU to providing the authentic version of the Agreement in the Croatian language.

2014/0222(NLE) - 29/09/2014 Legislative proposal

PURPOSE: to conclude, on behalf of the European Union and its Member States, of the Protocol to the Framework Agreement on Comprehensive Partnership and Cooperation between the European Union and its Member States, of the one part, and Vietnam, of the other part, to take account of the accession of Croatia to the European Union.

PROPOSED ACT: Council Decision.

ROLE OF THE EUROPEAN PARLIAMENT: Council may adopt the act only if Parliament has given its consent to the act.

BACKGROUND: in accordance with a Council Decision, the Protocol to the Framework Agreement on Comprehensive Partnership and Cooperation between the European Union and its Member States, of the one part, and Vietnam, of the other part, to take account of the accession of Croatia to the European Union has been signed, subject to its conclusion at a later date.

The Protocol should now be approved on behalf of the European Union and its Member States.

CONTENT: under this proposal, the Council is invited to adopt a decision seeking to approve the Protocol to the Framework Agreement on Comprehensive Partnership and Cooperation between the European Union and its Member States, of the one part, and Vietnam, of the other part, to take account of the accession of Croatia to the European Union.

The proposed Protocol incorporates Croatia as contracting party to the Agreement and commits the EU to providing the authentic version of the Agreement in the Croatian language.

2014/0222(NLE) - 23/11/2015 Committee report tabled for plenary, 1st reading/single reading

The Committee on Foreign Affairs adopted the report by Sandra KALNIETE (EPP, LV) on the draft Council decision on the conclusion, on behalf of the European Union and its Member States, of the Protocol to the Framework Agreement on Comprehensive Partnership and Cooperation between the European Union and its Member States, of the one part, and the Socialist Republic of Vietnam, of the other part, to take account of the accession of the Republic of Croatia to the European Union.

The committee recommended the European Parliament to give its consent to conclusion of the Protocol.

2014/0222(NLE) - 17/12/2015 Text adopted by Parliament, 1st reading/single reading

The European Parliament adopted by 533 votes to 51, with 46 abstentions, a legislative resolution on the draft Council decision on the conclusion, on behalf of the European Union and its Member States, of the Protocol to the Framework Agreement on Comprehensive Partnership and Cooperation between the European Union and its Member States, of the one part, and the Socialist Republic of Vietnam, of the other part, to take account of the accession of the Republic of Croatia to the European Union.

Parliament gave its consent to the conclusion of the protocol.

2014/0222(NLE) - 12/12/2016 Final act

PURPOSE: to conclude the Protocol to the Framework Agreement on Comprehensive Partnership and Cooperation between the European Union and its Member States, of the one part, and Vietnam, of the other part, to take account of the accession of Croatia to the European Union.

NON-LEGISLATIVE ACT: Council Decision (EU) 2016/2342 on the conclusion, on behalf of the European Union and its Member States, of the Protocol to the Framework Agreement on Comprehensive Partnership and Cooperation between the European Union and its Member States, of the one part, and the Socialist Republic of Vietnam, of the other part, to take account of the accession of the Republic of Croatia to the

European Union.

CONTENT: with this Decision, the Council approved, on behalf of the European Union and its Member States, the Protocol to the Framework Agreement on Comprehensive Partnership and Cooperation between the European Union and its Member States, of the one part, and Vietnam, of the other part, to take account of the accession of Croatia to the European Union.

With this Protocol, Croatia becomes a contracting party to the Protocol.

ENTRY INTO FORCE: 12.12.2016.
