Parliament has adopted the report by Mr Jos? Vasquez Fouz (PSE, E) relating to the following points: - inclusion of the Canary Islands in the scope of the directive; - relaxation of rules applicable to official inspections; - abolition of Member States' option to decide on exemptions under specific conditions from certain obligations imposed for the Community phytosanitary system; - adaptation of certain technical provisions in the annexes. Parliament is asking for specific protection measures adapted to the particular characteristics of the archipelago to be introduced before the phytosanitary rules are applied to the Canary Islands in full. As regards the exemptions to be abolished immediately, Member States must send the Commission the requisite information to enable certain aspects of the annex to the phytosanitary directive to be amended if necessary.?

The Council adopted this directive, although it supplemented the initial proposal in order to extend the application of certain measures provided for in Directive 77/93 for a period ending six months after the date by which Member States must apply future provisions on the annexes to the directive in order to protect French overseas departments and the Canary Islands. The Member States must transpose the directive by 1 January 1995.?
