## Court of Auditors: appointment of an Italian member

---

The Committee on Budgetary Control adopted the report by Indrek TARAND (Greens/EFA, EE) on the proposed nomination of Pietro Russo (IT) as a member of the Court of Auditors.

The committee evaluated the credentials of the nominee proposed by the Council, in particular in view of the requirements laid down in Article 286(1) of the Treaty on the Functioning of the European Union (TFEU). It then proceeded with the hearing of the candidate at its meeting of 19 October 2017.

Members called on the European Parliament to deliver a favourable opinion on the Council's nomination of Pietro Russo as a Member of the Court of Auditors.

The European Parliament voted favourably (506 votes to 81, with 66 abstentions) on the Council's nomination of Pietro Russo as a Member of the Court of Auditors.
