Decentralized Community agencies: establishment of the European Monitoring Centre for Drugs and Drug Addiction EMCDDA (amend. Regul. 302/93/EEC)

The proposal for a regulation from the Council entails a technical amendment to Article 11 of Regulation No 93/302/CEE, concerning financial provisions for the European Monitoring Centre for Drugs and Drug Addiction. Since the Monitoring Centre has its own budget, it must also have its own financial regulations to enable it to function as soon as it starts operations. It is therefore proposed that, after the Commission and the Court of Auditors have been consulted, the Management Board should adopt the internal financial provisions laying down rules for the establishment and implementation of the Centre's budget.?

Decentralized Community agencies: establishment of the European Monitoring Centre for Drugs and Drug Addiction EMCDDA (amend. Regul. 302/93/EEC)

A solution to the dispute over the financing of the European Monitoring Centre for Drugs and Drug Addiction, which is to be based in Lisbon, is now in sight after the committee adopted Mrs VAN DEN BRINK's draft report. At issue has been the extent of Parliament's control over the budget of EU satellite bodies, which has been of particular importance for the budgets committee. After Mrs VAN DEN BRINK said that a very satisfactory compromise had been reached the committee voted through the following amendment which the Commission representative also said was acceptable: - In principle the Financial Regulation applicable to the general budget of the European Community shall apply to the Centre. - Accordingly the management board shall adopt the internal financial provisions specifying, in particular, the detailed rules for implementing the Centre's budget after the Commission, the Court of Auditors and the European Parliament have delivered their opinion.

The European Parliament approved the Commission proposal subject to the following amendment: The financial regulation applicable to the general budget of the European Community applies in principle to the Monitoring Centre. Consequently, the European Parliament is also required to give its opinion (on an equal footing with the Commission and the Court of Auditors) before the management board decides on the internal financial arrangements for implementing the Monitoring Centre's budget.?
