## EC/Yemen agreement: cooperation agreement

The subject of this proposal for a regulation is the signature of an agreement in the form of an exchange of letters amending the cooperation agreement between the Community and the Yemen Arab Republic. The reason for the amendment is that the Yemen Arab Republic and the People's Democratic Republic of Yemen merged on 22 May 1990. The cooperation agreement originally signed between the Arab Republic of Yemen and the Community therefore has to be extended to the whole of Yemeni territory. ?

## EC/Yemen agreement: cooperation agreement

In 1984, the Community concluded a cooperation agreement with the Yemen Arab Republic. The Republic of Yemen was proclaimed on 22 May 1990, following the unification of the Yemen Arab Republic and the People's Democratic Republic of Yemen. ### EC/Yemen agreement: cooperation agreement

The Council adopted the decision concerning the conclusion of the agreement in the form of an exchange of letters amending the Cooperation Agreement between the European Community and the Yemen Arab Republic. The amendment related to the application of the agreement to the territory of the Republic of Yemen as a result of the unification of the Yemen Arab Republic and the People's Democratic Republic of Yemen on 22 May 1990. ?
