Legal units of measurement of the Système international SI, supplementary after 31/12/1999 (amend. Directive 80/181/EEC)

PURPOSE: to amend Council Directive 80/181/EEC on the approximation of the laws of the Member States relating to units of measurement. CONTENT: the Commission proposes two kinds of amendments. These are aligning Directive 80/181/EEC to international agreements and decisions, and extending the deadline concerning the use of supplementary indications. It is necessary to bring the Directive into line with agreements and decisions made at international level on units of the SI and their practical use. In addition, it is important that the time limit for the use of supplementary indications is extended until 31 December 2009. Moreover, the inclusion of a new Article 6a, obliges the Commission to re-examine the Directive and its operation and to adopt appropriate measures if necessary. It is also proposed that the re-evaluation and adoption of measures shall be carried out in consultation with the Committee set up by Directive 71/316/EEC (the framework Directive for legal metrology affairs) according to the procedure laid down by that Directive.?

Legal units of measurement of the Système international SI, supplementary after 31/12/1999 (amend. Directive 80/181/EEC)

The committee adopted the report (codecision procedure, first reading) by Mr Giles Bryan CHICHESTER (EPP/ED, UK) approving the Commission proposal amending the existing directive on the approximation of the laws of the Member States relating to units of measurement. Most of the proposed modifications enacted updates decided by the International Standards Organisation (ISO) and were technical in nature. The use of additional labellings in non-metric units had also been included in the original directive but only as a provisional measure, which was due to expire on 31 December 1999. However, it needed to be extended, as the reasons for its existence still applied. The Commission proposal provided for a further period of ten years, which met with the committee's approval. The report pointed out that, to avoid any legal uncertainty from 1 January 2000, the directive should enter into force as soon as possible. Under the new rules of the Amsterdam Treaty, approval of the Commission proposal by both the Council and Parliament without any amendments would allow the directive to be adopted with only one reading. The committee took the view that this was both feasible and desirable.?

PURPOSE: to amend Council Directive 80/181/EEC on the approximation of the laws of the Member States relating to units of measurement. COMMUNITY MEASURE: Directive 1999/103/EC of the European Parliament and of the Council. CONTENT: the amendments introduced by the Council concern two aspects : - on the one hand, the text of the Council Directive 80/181/EEC should be brought into line with the international agreements and standards of the Conférence générale des poids et mesures (1991) and The International Organisation for Standardisation (ISO); - on the other hand, the extension of the deadline for the use of the supplementary indications in non-legal units until 31/12/2009. The Commission shall re-examine the application of the Directive, and, if necessary adopt the appropiate measures in accordance with the procedure referred to in Article 18 of Council Directive 71/316/EEC (the framework directive for legal metrology questions).
