The aim of this proposal was to extend until 1 April 2000, which corresponded to the end of the scheme set up by Council Regulation (EEC) No 3950/92 establishing an additional levy in the milk and milk products sector, the ban on the marketing of BST and its administration to dairy cows, in accordance with Council Decision 90/218/EEC.?

Placing on the market and administration of bovine somatotrophin BST (amend. Directive 90/128/EEC)

Parliament welcomed this proposal. However, it tabled an important amendment in order also to prevent the import from third countries both of milk produced by cows to which BST had been administered and of products made from such milk or containing that type of milk product. Furthermore, the EP considered that the proposal should specify that there was no link between the ban on BST and the milk quota system. ?
