1994/95 AGRICULTURAL PRICES: In order to have greater control over the production of potato starch, it was proposed to make the granting of compensation payments to producers of potatoes intended for the production of starch, as provided for in Council Regulation (EEC) No 1766/92, conditional on the existence and submission of a cultivation contract between the producer and the starch manufacturer. To make the scheme easier to manage, it was also planned to relax the provisions governing the fixing of premiums and related corrective factors.?

The Regulation was formally adopted on 27.07.94 and was to apply as from 01.08.94, with the exception of the measures relating to whisky, which applied retrospectively since 01.07.93. ?
