Agricultural prices 1994/1995: monthly price increases for paddy rice

1994/95 AGRICULTURAL PRICES: It was proposed to freeze the minimum prices for A beet and B beet (ECU 38.69 and ECU 26.85/100 kg respectively), the derived intervention price for white sugar (between ECU 53.54 and ECU 54.27/100 kg depending on the areas), the intervention price for unrefined sugar (ECU 43.37/100 kg), and the threshold price (ECU 63.18/100 kg of white sugar, ECU 53.99/100 kg of unrefined sugar, ECU 6.80/100 kg of molasses). The monthly refund for storage costs was to fall by 32.69% to ECU 0.35/100 kg of white sugar to take account of the reduction in interest rates in the Community.?
