1994/95 AGRICULTURAL PRICES: It was proposed to keep the guide prices at the previous year's levels, i.e.: - type RI, RII and AI wines: ECU 3.17/% vol/hl; - type RIII wines: ECU 51.47/hl; - type AII wines: ECU 68.58/hl; - type AIII wines: ECU 78.32/hl. ?

The Regulation was formally adopted on 27.07.94 and was to apply from 01.08.94, with the exception of measures relating to the repayment of storage costs, which were to apply retrospectively from 01.07.94. ?
