Agricultural prices 1994/1995: production aid in the olive oil sector

1994/95 AGRICULTURAL PRICES: Pending its proposals on reforming the common organisation of the markets in the fresh fruit and vegetables sector and the processed products sector, the Commission proposed to keep the basic and buying-in prices at current levels. If the intervention thresholds were exceeded it would draw the appropriate conclusions once the final withdrawals for the 1993/94 marketing year were known.?

The Regulation was formally adopted on 27.07.94 and was to apply as from 01.11.94, with the exception of the possible implementation of measures aimed at solving the temporary problems resulting from the reduction in consumer aid and in the intervention price, which could be adopted as from 30.07.94. ?
