1994/95 AGRICULTURAL PRICES: Pending its proposals on reforming the common organisation of the markets in the fresh fruit and vegetables sector and the processed products sector, the Commission proposed to keep the basic and buying-in prices at current levels. If the intervention thresholds were exceeded it would draw the appropriate conclusions once the final withdrawals for the 1993/94 marketing year were known. ?
