Agricultural prices 1994/1995: target price for milk, intervention price of butter (amend. regul. 2072/92/EEC)

1994/95 AGRICULTURAL PRICES: It was proposed to keep the guide price at the previous year's level, i.e. ECU 197.42/100 kg live weight. For the intervention price, the second 5% reduction adopted as part of the reform of the CAP would bring the price down to ECU 304.71/100 kg carcass weight for R3 quality for the period from 1 July 1994 to 30 June 1995. ?
