1994/95 AGRICULTURAL PRICES: As part of the reform of the CAP, the Council had fixed the target price for milk and the intervention prices until 30 June 1995. However, since the 1993/94 marketing year ended on 31 March 1994, the Commission proposed, as in the previous year, to extend the current year until 30 June 1994 so that the threshold prices fixed, which were linked to the marketing year, remained consistent with the institutional prices fixed from 1 July to 30 June of the following year.?
