1994/95 AGRICULTURAL PRICES: The aim of this proposal was to amend the general rules of the system of aid for cotton in order to reduce fraud: at that time, aid was granted for the quantity of unginned cotton brought under supervision, adjusted according to the moisture and impurities content on arrival at the ginning plant. This quantity was supposed to correspond to the quantity actually delivered, but in practice it was greater, in order to obtain more aid. To prevent this it was proposed to establish a link with the quantities leaving the plant, checks on which were already provided for in Community regulations (stock accounts). From the 1994/95 marketing year, therefore, aid for ginned cotton would be granted for the smaller of the following two quantities: - the quantity of unginned cotton brought under supervision; - the quantity of unginned cotton calculated as the quantity of fibres obtained divided by the yield for the standard quality (32%).?
