## Agricultural prices 1994/1995: basic price and standard quality for pig carcasses

1994/95 AGRICULTURAL PRICES: The aim of this proposal was to abolish consumption aid for olive oil in favour of production aid alone, and therefore to also abolish the representative market price from which the aid was calculated. Abolishing the representative price meant that the rules governing the calculation of the threshold price also had to be amended; this would no longer be derived from the representative market price, but would be the target price minus the production aid and unloading and forwarding costs. In addition, following the abolition of consumption aid, consumption promotion measures would be funded by an annual appropriation of ECU 10 million for projects within the Community and a maximum of ECU 5 million as a Community contribution to the budget of the International Olive Oil Council for promotion in third countries. Finally, the provisions on monitoring were to be simplified, with future checks able to focus on the production stage now that the consumption stage was no longer assisted.?

## Agricultural prices 1994/1995: basic price and standard quality for pig carcasses

The committee voted this morning to accept the report by Mr DEBATISSE (EPP, F) on the 1994 agricultural prices package with the exception of the part dealing with the dairy sector. As was noted before, Mr DEBATISSE points out in his report that the 1994/95 marketing year will be the second year of the transitional stage leading to the full implementation of the 1992 CAP reform. Thus, these proposals represent a 'mini-package' of measures, making changes only where considered essential. However, this adherence to 'the letter of the law', argues the rapporteur, cannot hide the fact that the only concern underlying the 34 proposals for regulations is of a budgetary nature. Therefore, in general the amendments put forward by the rapporteur to the Commission's proposals aim to alleviate their negative impact on farmers' incomes. This is seen as particularly important in view of the double blow dealt to European agriculture by CAP reform and the GATT agreement. Significant amendments were adopted in the beef meat, dried fodder, durum wheat and linseed oil sectors.?
