### EC/Angola fisheries agreement: protocol for the period from 3 May 1994 to 2 May 1996

This proposal aimed to conclude the renewal of the fisheries agreement between the Community and Angola for the period from 3 May 1994 to 2 May 1996. This agreement would provide the Community with the following fishing opportunities in Angolan waters: - shrimp vessels: 6 550 GRT per month, as an annual average, with 30% pink shrimps and 70% common shrimps; - demersal trawlers: 1 900 GRT per month, as an annual average; - bottom set longliners and fixed gillnets: 900 GRT per month, as an annual average. Fishing for centrophorus granulosus was forbidden. In return, Angola would receive: - financial compensation of ECU 13 900 000; - financing to the tune of ECU 2 800 000 for scientific and technical programmes relating to fisheries; - training and study grants relating to fisheries disciplines, for Angolan nationals, amounting to ECU 1 800 000.?

The committee also adopted the report by Mr Jose APOLINARIO (PES,PORT) revising for the third time the fihseries agreement, , dating form 1987, between the Community and Angola. Members had little problem with the substance of the Commission's proposals, but called on the Commission to provide better information in the future and in particular to provide a detailed report on the implementation of the agreement in advance of any negotiating mandate being granted for futur protocols.

Parliament approved the Commission proposal subject to four amendments: - each year, the Commission should submit a report to the budgetary authority on the progress made in the implementation of the agreement in order to facilitate decision-making in the context of the annual budget procedure; - the Commission should submit to the Council and the European Parliament, during the last year of the agreement and before the conclusion of any renewal of the agreement, a report on the application and implementing conditions of the agreement; - the Council's mandate to the Commission to negotiate the protocols for the application of the agreement was subject to a Commission report following consultation of the European Parliament.?
