# NAFO Pilot Observer Scheme applicable to fishing vessels operating in the North-West Atlantic

This proposal aimed to amend Regulation (EEC) 3928/92 adopting a NAFO pilot observer scheme applicable to Community vessels operating in the Regulatory Area of the Northwest Atlantic Fisheries Organisation in order to extend the duration of this programme by six months (i.e. until 31 December 1994 instead of 30 June 1994), in accordance with the decision adopted by the contracting parties to NAFO at the meeting of the special session of the NAFO Fisheries Commission in February 1994.?

# NAFO Pilot Observer Scheme applicable to fishing vessels operating in the North-West Atlantic

The report was accepted (with one vote against), approving the extension by 6 months until the end of 1994 of the agreement between the EU and the other members of the Northwest Atlantic Fishing Organisation (NAFO) concerning a pilot scheme to provide observers on fishing vessels. As the rapporteur pointed out there was little real choice open to the committee, since the Commission had already agreed the extension with our partners and the extension period was already half way through. In approving the Commission's proposal therefore, Members adopted two amendments to the effect that the Commission should submit a report on the implementation of the scheme to the Council and the Parliament, before agreeing any further prolongations in the future. ?

### NAFO Pilot Observer Scheme applicable to fishing vessels operating in the North-West Atlantic

Parliament approved the Commission proposal subject to two amendments. They aimed to ensure that the Commission submitted to Parliament and the Council a report on the implementation and impact of the pilot scheme before agreeing any further prolongations of the programme within the NAFO Fisheries Commission and that it submitted any new proposals concerning the NAFO Joint International Inspection Scheme.?

### NAFO Pilot Observer Scheme applicable to fishing vessels operating in the North-West Atlantic
