Integrated programme in favour of small and medium-sized enterprises (SMEs)

The purpose of this communication is to establish an integrated action programme for SMEs, to replace projects under way and propose new projects. It will include the following lines of approach: Under measures to improve the environment for enterprises: - Community legislation will take account of the needs of enterprises; - the conditions for transferring enterprises will be improved; - the tax environment for SMEs will be improved (a specific recommendation has been tabled in parallel to this programme); - payment periods between enterprises will be improved; - new jobs will be created in local services. Under support measures for enterprises: - access to financing and credit will be improved; - support will be given to cooperation between enterprises; - support will be given to improving management quality. This integrated programme does not have any additional budgetary implications and comes within the financial perspectives for 1993-99. It mainly comes under: - the growth initiative and the European Investment Fund; - the multiannual programme in favour of enterprises; - the decision by the European Council in Copenhagen to increase the resources of the EIB temporary loan facility; - the Council resolution of 22 November 1993 on strengthening the competitiveness of enterprises and promoting employment; - the White Paper on growth, competitiveness and employment; - the conclusions of the Brussels European Council in December 1993; - the EIB decision to implement subsidized loans; - the Community initiative in favour of SMEs; - the ADAPT initiative.?

Integrated programme in favour of small and medium-sized enterprises (SMEs)

The resolution adopted stresses that, although the European Parliament welcomes the choice of an integrated approach, it trusts that this approach will result in greater coordination, transparency, efficiency and coherence as regards the initiatives themselves, the aim being to avoid any wastage of resources. The specific measures contained in the resolution include: - simplifying the administration imposed on SMEs, especially by ensuring that the transposition of Union directives into national legislation does not increase their costs; - the need for the Commission to table coercive proposals in order to regulate the problem of late payments. Both Union institutions and national administrations should set an example here by reducing their backlog of overdue payments; - the need for the Commission to present programmes, with which SMEs are associated, outlining certain ideas for creating jobs in sectors such as local services and environmental protection; - simplifying the procedure used by SMEs to access EU funds; - the need for the Commission to study how to give financial institutions a better understanding of the problems faced by SMEs, possibly by developing a system of seconding staff to SMEs, - the need, within the framework of the Leonardo da Vinci programme, to allocate suitable appropriations to vocational training in order to ensure that SMEs can acquire the qualifications needed in order to adapt to industrial change.?
