Amendment of the Financial Regulation of 21.12.1977 applicable to EC budget: clearance of EAGGF accounts

This proposal was linked to the proposal aimed at revising Regulation (EEC) no 729/70 on the financing of the CAP. The changes envisaged, namely the division of the procedure for the clearance of accounts into two distinct procedures - the rendering and approval of accounts on one hand, and checks on conformity on the other - had the effect of adapting the financial regulation of 31 December 1997, which applied to

Amendment of the Financial Regulation of 21.12.1977 applicable to EC budget: clearance of EAGGF accounts

The committee accepted the idea proposed by the Commission to divide the procedure into two sections: - "first section": "clearance of accounts", - "second section": phase concerning financial corrections, including an aspect on an amicable agreement, and a second aspect on the contentious phase before a conciliation body. It thus accepted the establishment of a procedure for the accreditation of paying agencies in the Member States. It agreed to a rolling program for the clearance of accounts which should last no longer than three years. This system should in turn result in a rolling discharge being granted on a case-by-case basis. Through the amendments it adopted in approving the report by Rosemarie WEMHEUER (PSE, D), the Committee on Budgetary Control aimed to strengthen the Commission's right to carry out checks, ensure consistency in the standards required for the accreditation of paying agencies in the Member States, and finally, ensure that the EP had all the relevant information with regard to the clearance of accounts to enable it to give its opinion on the discharge. The report also called on the Court of Auditors to submit a report to the EP on each clearance decision. ?

Amendment of the Financial Regulation of 21.12.1977 applicable to EC budget: clearance of EAGGF accounts

The Committee on Budgetary Control adopted the second report by Mrs WEMHEUER, thus approving the Commission proposal to divide the procedure for the clearance of accounts into two sections. The amendments adopted aimed, in particular, to: - strengthen the Commission's right to carry out checks: it should be entitled and enabled to carry out all checks into the management of expenditure it considered necessary; - ensure effective transparency and mutual assistance between the Member States and the Commission; - ensure consistency in the standards required for accreditation of paying agencies in the Member States: to this end, the Commission should set out detailed instructions on the criteria to be applied and ensure that they were respected throughout the Community; - ensure that the Commission had full and immediate access to information on expenditure. The amendment aimed at ensuring that the EP had all the relevant information with regard to the clearance of accounts to enable it to give its opinion on the discharge (Amendment No 6 to the first report by the Committee on Budgetary Control) became the new Amendment No 2 to the proposal for a regulation amending the Financial Regulation of 21 December 1977.?

Amendment of the Financial Regulation of 21.12.1977 applicable to EC budget: clearance of EAGGF accounts

The European Parliament approved the Commission proposal, subject to certain amendments aimed at providing Parliament with the all the relevant information with regard to the clearance of accounts to enable it to give its opinion on the discharge. Parliament asked in particular that: - each clearance decision under the second stage of the new procedure (compliance audits) be forwarded to the European Parliament for discharge; - a protocol be drawn up between Parliament and the Commission to establish the methods for providing the documents needed for this procedure; - arrangements be adopted to enable the Court of Auditors to submit to the EP a report on each clearance decision. ?

Amendment of the Financial Regulation of 21.12.1977 applicable to EC budget: clearance of EAGGF accounts

The Commission incorporated in its amended proposal the vast majority of the amendments adopted by Parliament in its plenary session.

Among other things, these amendments will give Parliament the possibility to receive useful information in relation to the clearing of the accounts in the course of exercising its discharge role (e.g. conformity audits).

The Commission also took account of Parliament?s demand to be immediately informed of all documents useful for the discharge procedure.

Amendment of the Financial Regulation of 21.12.1977 applicable to EC budget: clearance of EAGGF accounts

OBJECTIVE: amendment of the Financial Regulation applicable to the general budget of the Communities. COMMUNITY MEASURE: Council Regulation 2444/97/EC. SUBSTANCE: The Council has amended the Financial Regulation of 21 December 1997 applicable to the general budget of the Communities with a view to aligning it to the new clearance of accounts procedure for the EAGGF Guarantee section, established by Regulation 1287/95/EC amending Regulation 729/70/EEC on the financing of the common agricultural policy. The amendment seeks to specify in particular the budgetary treatment of decisions to refuse financing by the Fund of expenditure not disbursed in accordance with Community rules. This is the sixth series of amendments of the Financial Regulation which follows the conciliation procedure with the European Parliament on the joint guidelines drawn up by the Council in November 1995.
