Agriculture, aid schemes: integrated administration and control system (amend. Regul. 3508/92/EEC)

This proposal aimed to extend by one year, until 1 January 1996, the period of Community financial contributions laid down in Regulation 3508/92/EC establishing an integrated administration and control system for certain Community aid schemes. In fact, the implementation of this system highlighted significant problems, particularly with regard to the creation of the alphanumeric systems for the identification of agricultural parcels, which required large investments after the end of the period laid down. ?

Parliament approved the Commission proposal subject to three amendments. These amendments were designed to: - specify that the limit of the allocations granted would be established during the budgetary procedure; - ensure that the Commission submitted a report to the Council and Parliament before the end of 1995 on the operation of the integrated system, together with annual reports until the end of the operation of the system on the results in all the Member States; - fix the date on which the regulation expired irrevocably as 31 December 1995. The Commission did not accept these amendments. ?

The Council regulation extended by one year, in other words until 1 January 1996, the period for Community financial contributions provided for under Regulation (EEC) No 3508/92 establishing an integrated administration and control system for certain Community agricultural aid schemes. In fact, the implementation of this system had encountered certain problems, particularly in setting up the alphanumeric systems for the identification of agricultural parcels, which required large investments after the end of the three-year period initially laid down. ?
