# HANDYNET: continued development of the HANDYNET system 1995-1996 in the framework of HELIOS II for disabled people

This proposal for a decision aimed to continue the development of the HANDYNET system achieved within the framework of the HELIOS II programme for disabled persons from 1 January 1995 to 31 December 1996. HANDYNET was a European multilingual computerised information system designed to provide information for disabled persons. The aim of this decision was to create two new information modules within the current system: the first relating to training and employment for disabled persons and the second relating to access to public places. Other amendments were provided for in relation to the dissemination of information (dissemination by CD-ROM for example). ?

## HANDYNET: continued development of the HANDYNET system 1995-1996 in the framework of HELIOS II for disabled people

The committee adopted the report on the HANDYNET computerized information and documentation system, introduced in 1988 within the framework of the HELIOS II Programme. The system provides a databank designed to assist disabled people and provides information on technical aids manufactured within the Community. The Commission is proposing that the system should continue and be extended to include two mew modules concerned with training, employment and accessibility of public places. The committee adopted amendments to the Commission proposals calling in particular for the limitation of the HANDYNET system to the technical aids module of the database and considered that the information within it should be extended to include a quality criterion. In addition, they demanded the greater availability of this data to European, national and regional representative bodies concerned with disabled people. Finally, the committee adopted an amendment calling for a report by the Commission to be submitted by 31 December 1995 at the latest, which would evaluate the HANDYNET system and take into account the opinions of all representative organizations for disabled people.?

Parliament approved the Commission proposal subject to six amendments. These amendments aimed to: - encourage the continuation of the Handynet system but limit the exiting database to the technical aids module; - stress the need to promote conditions to facilitate distribution of the system; - ensure that the Commission reported on measures taken to facilitate access to the system for users and on arrangements for financial implementation; - ensure that Handynet established effective cooperation with ISO and CEN with a view to including European standards at an early date in the technical aids database; - modify the system before 31 December 1996 in such a way that the Commission and the national data collection centres cooperated in the distribution of the data and the CD-ROM was made available free of charge to all representative bodies concerned with disabled people; that the information in the technical aids module was rendered compatible with the data on the research and technological development programmes in the framework of TIDE; and that the costs were borne pro rata by the parties involved; - ensure that the Commission submitted to Parliament and the Council, no later than 31 December 1995, an external evaluation of the system, indicating clearly the number of people who were using the database, for which purpose the opinions of all representative organisations for disabled people should be sought. The Commission accepted all these amendments. ?
