## Compliance with international conservation and management measures by fishing vessels on the high seas

In order to discourage the practice of requesting the allocation or change of flag by fishing vessels in order to circumvent international measures for the conservation and management of living marine resources, the FAO (Food and Agriculture Organisation of the United Nations), of which the Community was a member, negotiated an Agreement to promote compliance with international conservation and management measures by fishing vessels on the high seas. The Agreement clarified the states' responsibilities with regard to flags and stipulated that the signatories should make all efforts to ensure that vessels did not engage in any activity that undermined the conservation or management of biological resources. In particular, the Agreement stipulated that the states should establish a system to authorise fishing in the high seas and that they should carry out a series of controls before granting this authorisation and throughout its period of validity. Moreover, states should provide for sanctions in order to guarantee respect for the Agreement. This proposal for a decision was aimed at enabling the Community to accept the Agreement.?

## Compliance with international conservation and management measures by fishing vessels on the high seas

The committee unanimously adopted the report by Mrs LANGENHAGEN supporting the accession of the EU to the FAO agreement to promote compliance with international conservation and management measures by fishing vessels on the high seas. The agreement aims to improve conservation of fish stocks outside the 200 nautical mile limit.

### Compliance with international conservation and management measures by fishing vessels on the high seas

Parliament approved the Commission proposal subject to the amendment it tabled. This amendment called on the Commission to submit to the Council and the European Parliament, on an annual basis, a report on the implementation of the agreement. The Commission did not accept this amendment.?

# Compliance with international conservation and management measures by fishing vessels on the high seas

OBJECTIVE: to enable the Community to accede to the Agreement to promote compliance with international conservation and management measures by fishing vessels on the high sea. COMMUNITY MEASURE: Council Decision 96/428/EC SUBSTANCE: the Community's

accession to this agreement, which concerns the conservation and management of the biological resources of the high seas, is the outcome of protracted discussions during 1994 and 1995 and the judgment delivered by the European Court of Justice on 19 March 1996 in case C-25/94 on the right to vote in the FAO on the occasion of the adoption of the agreement in question. ?
