EEA Agreement: amending Protocol 31 to include the 4th framework research programme RTD

This decision by the European Economic Area Joint Committee sought to amend Protocol 31 of the EEA Agreement on cooperation in specific fields outside the four freedoms. The decision aimed to enable the EFTA/EEA states to participate in the Community's fourth framework programme for research and development. Given that this decision by the EEA Joint Committee supplemented the EEA Agreement itself, the Council of the European Union considered that the decision should be approved by itself after having received the opinion of the European Parliament. ?
