## EEA Agreement: amending Protocol 31 on cooperation in specific fields

This decision by the European Economic Area Joint Committee (No 8/94 of 1 June 1994) sought to amend Protocol 31 of the EEA Agreement on cooperation in specific fields outside the four freedoms. It involved technical amendments aimed at determining the participation of EFTA states in a series of Community programmes or actions relating to several fields of the Union's policy (information services, environment, training, social policy, consumer policy, audiovisual, trade and transport). Given that this decision by the EEA Joint Committee supplemented the EEA Agreement itself, the Council of the European Union considered that the decision should be approved by itself after having received the opinion of the European Parliament.?
