## EEA Agreement: amend. the Protocol 31 on the European Environment Agency

This decision by the European Economic Area Joint Committee sought to amend Protocol 31 of the EEA Agreement on cooperation in specific fields outside the four freedoms. It involved a decision aimed at enabling the EFTA/EEA states to participate fully in the European Environment Agency, established by the Community's Regulation No 1210/90/EEC. Given that this decision by the EEA Joint Committee supplemented the EEA Agreement itself, the Council of the European Union considered that the decision should be approved by itself after having received the opinion of the European Parliament.?
