Generalized system of preferences: revision of the system 1995-1997 for agricultural products

This proposal for a regulation aimed to extend until 31 December 1995 the application of Regulations (EEC) Nos 3833/90, 3835/90 and 3900/92 applying generalised tariff preferences in respect of certain agricultural products originating in developing countries. This extension was justified by the time needed to implement a new tariff system as a result of the Uruguay Round for agriculture, fisheries and processed agricultural products. Specific adjustments were however envisaged, particularly for certain products from countries that were engaged in combating the production and trafficking of drugs (Andean countries). ?

Generalized system of preferences: revision of the system 1995-1997 for agricultural products

Parliament approved the Commission proposal subject to two amendments. These amendments aimed to: - supplement the reference to Article 113 of the Treaty establishing the European Community (common commercial policy) by expressly invoking Article 43 (common agricultural policy) and Article 130w (application of the cooperation procedure to the adoption of measures necessary to achieve the objectives of the Community's policy in the field of development cooperation) as legal bases of the proposal; - exclude from the system suspending Common Customs Tariff duties products under codes 20056000 and 20049099 (canned and frozen asparagus). ?

Generalized system of preferences: revision of the system 1995-1997 for agricultural products

The Council adopted Regulation (EC) No 3282/94 aimed at extending by one year (until 31 December 1995) the application of Regulations (EEC) Nos 3833/90 and 3900/91 applying generalised tariff preferences in respect of certain agricultural products originating in developing countries. In addition to this extension, South Africa was added to the list of beneficiary countries for certain agricultural products (on the understanding that it would be reviewed before 1 July 1995) and specific adjustments were envisaged for certain products from countries that were engaged in combating the production and trafficking of drugs (Andean countries, countries in Central America and Venezuela, including for certain fisheries products). ?
