Exceptional Community aid for reconstruction of the areas stricken by the cyclone in Madeira, Portugal

The proposal for a decision relates to exceptional Community aid for the reconstruction of zones devastated by the cyclone which hit Madeira in October 1993. This involves providing Portugal with an interest rate subsidy, chargeable to the Community budget, on loans granted by the EIB (European Investment Bank) out of its own resources. The total amount of this interest subsidy (3% of the annual interest rate) would come to ECU 15.85 million for a maximum period of 12 years. The reconstruction projects are to be put forward by the Portuguese authorities and approved by the EIB. ?

Exceptional Community aid for reconstruction of the areas stricken by the cyclone in Madeira, Portugal

The Committee adopted the report presented by its chairman, Mr Roberto Speciale (PSE, I), on the provision of exceptional Community aid for the reconstruction of zones devastated by the cyclone which hit Madeira in October 1993. This comprises an exceptional loan of ECU 15.85 million, to be financed by the European Investment Bank. This represents 50% of the possible real cost of eligible reconstruction projects. An interest rate subsidy of 3% per year, for a maximum period of 12 years, is also provided for. The Committee on Regional Policy proposed three amendments to the Council's decision, the aims of which were: - to specify that the loans are intended for financing projects undertaken between 1993 and 1997 with respect to the reconstruction of devastated areas, including infrastructure projects, preventive actions and measures aimed at restoring essential living conditions for the people, - to ensure that the loans are granted by the Portuguese authorities in collaboration with the regional and local authorities and the social partners, - to see to it that the Commission, in close cooperation with the EIB, keeps Parliament and the Council informed of the implementation and results of the financing initiative. ?

The European Parliament approved this proposal for a decision with the following amendments: - the loans were intended for the financing of projects undertaken between 1993 and 1997 with respect to the reconstruction of cyclone-stricken areas, particularly infrastructure projects, preventive actions and measures aimed at restoring essential living conditions for the people; - loans were granted on the basis of projects put forward by the Portuguese authorities in collaboration with the regional and local authorities and the social partners; - the Commission, in close cooperation with the EIB, would keep Parliament and the Council informed of the implementation and results of the financing initiative before 31 December 1998. ?

Exceptional Community aid for reconstruction of the areas stricken by the cyclone in Madeira, Portugal

OBJECTIVE: to provide Portugal with an interest rate subsidy of 3%, chargeable to the budget of the European Communities, on some loans granted by the European Investment Bank (EIB) out of its own resources for the financing of projects in the regions devastated by the cyclone that hit Madeira in October 1993. COMMUNITY MEASURE: Council Decision 95/250/EC relating to exceptional Community aid for the reconstruction of the areas stricken by the cyclone that hit Madeira in October 1993. SUBSTANCE: The Community provides Portugal with an interest rate subsidy of 3% per year, chargeable to the EC budget, on the loans granted by the EIB out of its own resources for the financing of projects in the regions devastated by the cyclone that hit Madeira in October 1993. The total amount of subsidised loans comes to ECU 15.85 million for a maximum period of twelve years. The loans are intended for the financing of projects undertaken between 1993 and 1997 for the reconstruction and redevelopment of cyclone-stricken areas (infrastructure works and, secondarily, housing). They are granted by the EIB on the basis of projects put forward by the Portuguese authorities. The detailed arrangements for implementing this Decision are laid down in a cooperation agreement between the Commission and the EIB, setting out, in particular, the detailed rules for the payment of the interest rate subsidies. The Commission will present to the European Parliament and the Council - in close cooperation with the EIB and before 31 December 1998 - a report on the implementation and results of this financing (in particular on the additional effects produced by the interest subsidies). ENTRY INTO FORCE: 29 June 1995. ?
