## Hops: aid to producers for the 1986 harvest

The proposal seeks to amend Regulation (EEC) No 2997/87 laying down, in respect of hops, the amount of aid to producers for the 1986 harvest and providing for special measures for certain regions of production. In view of the fact that certain Member States have encountered practical problems when implementing their varietal conversion programme for hops, the proposal seeks: - to extend from 1994 to 1996 the duration of the conversion plans in Spain, Portugal and Belgium; - to extend from 1994 to 1995 the duration of the conversion plans in the United Kingdom. ?
