The proposal for a regulation seeks to amend Regulation (EEC) No 3013/89 on the common organization of the market in sheepmeat and goatmeat. The measures proposed sought: - to ensure that, under certain conditions, specific groups of producers could be exempted from payment to the national reserve of the percentage of rights provided for in the case of a transfer of rights without transfer of holding; - to create a special reserve for Italy and Greece with a ceiling of 600,000 rights which the producers concerned were unable to claim since the 1991 marketing year was a year of transition for those Member States. The Regulation would apply as from the 1995 marketing year. ?
