Agricultural prices 1995/1996: cereals, common organisation of the markets COM (amend. Regul. 1766/92/EEC)

Cereals: marketing year 1995/1996. The proposal for a Council Regulation aims to amend Regulation (EEC) No 1766/92 on the common organization of the market in cereals. The reform of the CAP has made it possible to restore the market balance between Community production and the opportunities for sale and distribution. In these circumstances it was not necessary to apply the intervention arrangements at the beginning of the marketing year. In fact quite the reverse, as the intervention scheme should only act as a safety net towards the end of the marketing year in the event of unforeseen surpluses arising. As a result, the Commission proposed: - postponing the start of the intervention period: . for Italy, Spain, Greece and Portugal from 1 August to 1 October, . for Sweden, from 1 December to 1 February, . for the other Member States, from 1 November to 1 January. - abolishing the target price, which has been rendered unnecessary by the introduction of a fixed import duty, instead of a variable levy, under the GATT negotiations. ?

Agricultural prices 1995/1996: cereals, common organisation of the markets COM (amend. Regul. 1766/92/EEC)

Although aware that neither the Commission nor the Committee on Budgets were in favour of a 1% linear increase in all prices, the rapporteur, Mr HAPPART, urged Parliament to give farmers a sign of hope and support the most disadvantaged areas in Europe. Changing the timetable for the intervention periods, and in particular bringing forward the date for cereals, would have a dynamic effect; however, the Commissioner felt that postponing intervention by two months would have a positive impact on the cereals market. The rapporteur also believed that the

monthly price increases for cereals should be maintained at the level of the previous marketing year, in view of the fact that a fall in their prices had no connection with a parallel fall in storage costs; the Commissioner opposed this amendment however. He stated that he could accept the proposals on the ?price package? but could not take over the amendments that risked increasing spending excessively.

Agricultural prices 1995/1996: cereals, common organisation of the markets COM (amend. Regul. 1766/92/EEC)

The European Parliament approved the Commission proposal. It asked that the current provisions under which cereals with a specific humidity content were subject to intervention be maintained in the 1995/1996 financial year. It also opposed the proposal that the intervention period should begin two months later than in the previous financial year. The European Parliament rejected the request by its Committee on Agriculture for a 1% linear increase in agricultural prices for 1995/1996.?

Cereals: marketing year 1995/1996. The Council adopted Regulation (EC) No 1529/95 amending Regulation (EEC) No 1766/92 on the common organisation of the market in cereals. Substance: - maintaining the 1994/1995 timetable for opening the intervention period; - abolishing the target price, with the variable levy on imports due to be replaced by a fixed import duty.?
