## Agricultural prices 1995/1996: monthly price increases for cereals

Cereals: marketing year 1995/1996. It was proposed to reduce the monthly price increases for cereals by 10%, that is to say to restore them to ECU 1.3/tonne per month, to take account of the reduction in financing costs resulting from the final reduction in cereal prices and the reductions in short-term interest rates. As the start of the intervention period was to be postponed by two months, it was proposed that the period for monthly price increases should also begin two months later. ?

The European Parliament opposed the proposal for a 10% reduction in monthly price increases and stated that quantities of durum wheat which met the quality criteria implemented during the 1994/95 marketing year should be accepted for intervention. ?

## Agricultural prices 1995/1996: monthly price increases for cereals

Cereals: prices and related measures for 1995/1996. The Council adopted Regulation (EC) No 1529/95 fixing the monthly price increases for cereals for the 1995/1996 marketing year. Substance: - reducing by approximately 10%, to ECU 1.3/tonne per month, the amount of the monthly increase in intervention prices; - maintaining the 1994/1995 timetable for opening the intervention period. ?
