## Agricultural prices 1995/1996: rice, common organisation of the market COM (amend. regul. 1418/76/EEC)

Rice - agricultural prices 1995/1996. The proposal aims to amend Regulation (EEC) No 1418/76 on the common organization of the market in rice. The measures proposed are as follows: - to remove all reference to the target price, the implementation of the GATT agreements having resulted in the abolition of threshold prices in the market organization; - to adjust the provision concerning the calculation of the compensatory allowance for husked rice, with the calculation to be based on the buying-in price multiplied by 1.8; - to clarify, with a view to avoiding the risk of fraud, point A of the Annex to the basic regulation relating to the mensuration of grains so that grains which are not fully ripe are considered as whole grains; - to establish a method for determining the percentage by weight of broken rice in a batch, in order to enable importers to determine the rate of levy to be applied to the rice which they are importing.?

The European Parliament rejected the request by its Committee on Agriculture for a 1% increase in agricultural prices for 1995/1996. It favoured the reintroduction of special aid for indica rice at its previous level for the 1995/1996 marketing year at ECU 100/ha, in order to encourage efforts initiated by the Union to change to other varieties. Furthermore, with regard to the trading system with third countries, the EP called on the Commission to submit a legislative proposal based on considerations such as ceiling prices, import prices and import systems. ?

Rice - Prices and related measures for 1995/1996. The Council adopted Regulation (EC) No 1530/95 amending Regulation (EEC) No 1418/76 on the common organisation of the market in rice. Substance: - removal of all references to the target price, implementation of the GATT agreements entailing the abolition of threshold prices in the market organisation; - adjustment of the provision concerning the calculation of the compensatory allowance for husked rice; the calculation should be based on the buying-in price multiplied by 1.8; - consideration of grains which were not fully ripe together with whole grains when classifying broken rice for the purposes of applying import levies, with a view to avoiding the risk of fraud. ?
