Rice - Prices and related measures for 1995/1996. The Council adopted Regulation (EC) No 1531/95 fixing the intervention price for paddy rice for the 1995/1996 marketing year. Substance: - maintaining the intervention price for paddy rice at its current level, namely ECU 373.84/tonne. The Regulation would apply from 1 September 1995. ?
