Agricultural prices 1995/1996: monthly price increases for paddy rice and husked rice

Rice: agricultural prices 1995/1996. It was proposed for the marketing year 1995/1996: - to reduce the monthly increases by 2.5% and to fix their amount at ECU 2.28 per tonne for the intervention price and buying-in price of paddy rice and husked rice; - that the monthly increases should apply to the intervention price and buying-in price from 1.01.1996 to 1.07.1996, with the prices thus obtained for the month of July 1996 remaining valid until 31.08.1996. The Regulation would apply from 01.09.1995. ?

Agricultural prices 1995/1996: monthly price increases for paddy rice and husked rice

The European Parliament rejected the request by its Committee on Agriculture for a 1% increase in agricultural prices for 1995/96. It approved the proposal with one amendment, which called for the level of monthly price increases to be fixed at ECU 2.34 per tonne for the intervention price and buying-in price. ?

Agricultural prices 1995/1996: monthly price increases for paddy rice and husked rice

Rice - Prices and related measures for 1995/1996. The Council adopted Regulation (EC) No 1532/95 fixing the monthly price increases for paddy rice and husked rice for the 1995/1996 marketing year. Substance: - monthly increases were reduced by 2.5% and fixed at ECU 2.28 per tonne for the intervention price and buying-in price; - monthly increases would apply to the intervention price and buying-in price from 1 January to 1 July 1996; the prices obtained in the month of July 1996 would apply until 31 August 1996. The Regulation would apply from 1 September 1995. ?
