Agricultural prices 1995/1996: sugar prices and standard quality of beet

Sugar: agricultural prices 1995/1996. The Commission proposed placing a "freeze" on the basic price of beet, the intervention price for white sugar and the manufacturing margin. As regards white sugar it was proposed: - to fix the target price at ECU 66.5 per 100 kg; - to fix the intervention price at ECU 63.19 per 100 kg for non-deficit areas of the Community. It was also proposed to fix the basic price for beet in the Community at ECU 47.67 per tonne delivered at the collection centre. Beet of standard quality should: - be of sound, genuine and merchantable quality, and - have a sugar content of 16% at the point of reception. ?
