Agricultural prices 1995/1996: prices, aids and aid to be retained in the olive oil sector

Olive oil: marketing year 1995/1996. The proposal for a regulation seeks to fix prices, aids and percentages of aid to be retained in the olive-oil sector for the marketing year 1995/96. The Commission proposed: - to maintain the target price for olive oil at the 1994/95 level, namely ECU 383.77 per 100 kg; - to fix the intervention price and representative market price at their 1994/1995 levels: . intervention price: ECU 191.92 per 100 kg . representative market price: ECU 229.5 per 100 kg. It was also proposed that the percentages of aid to be retained (by way of actions designed to improve oil quality and assist producers' organizations), which have been significantly altered in the past, mainly as a function of aid modifications, should remain unchanged. ?

Agricultural prices 1995/1996: prices, aids and aid to be retained in the olive oil sector

The European Parliament rejected the request by its Committee on Agriculture for a 1% increase in agricultural prices for 1995/1996. The EP approved the Commission proposal. Through its amendments, it called for the creation of a Community fund to improve the quality and production of olive oil in the Union. It also called on the Commission to submit a report to the EP on the possibilities of using the residue from the extraction of olive oil as a renewable energy source, possibly accompanied by measures to develop this activity. ?

Agricultural prices 1995/1996: prices, aids and aid to be retained in the olive oil sector

Olive oil - Prices and related measures for 1995/1996. The Council adopted Regulation (EC) No 1535/95 fixing, for the 1995/96 marketing year, the prices, aids and percentages of aid to be retained in the olive oil sector. Substance: - maintaining the target price at the 1994/95 level, namely ECU 383.77 per 100 kilograms. - maintaining the intervention price and representative market price at their 1994/95 levels, in

other words: . intervention price: ECU 191.92 per 100 kilograms; . representative market price: ECU 229.5 per 100 kilograms. - maintaining aid for production and consumption aid and the percentages of these aids which could be withheld to improve the quality of olive oil and for organisations of olive-oil producers. - doing away with the threshold prices. The Regulation should apply from 1 November 1995. ?
