Agricultural prices 1995/1996: guide price for unginned cotton

Cotton: agricultural prices 1995/1996. The proposal for a regulation provided for the target price of non-ginned cotton to be fixed at ECU 122.51 per 100 kg for the marketing year 1995/96 (the price remaining unchanged from that of the previous year). The price relates to cotton which: - is of sound, genuine and merchantable quality, - contains 10% moisture and 3% impurities and - has the necessary properties to obtain, after ginning, 54% of seeds and 32% of fibres of grade no. 5 (white middling) and 28 mm in length (1-3/32"). The Regulation would apply from 1.09.1995. ?

Agricultural prices 1995/1996: guide price for unginned cotton

The European Parliament rejected the request by its Committee on Agriculture for a 1% increase in agricultural prices for 1995/1996. The EP approved the Commission proposal. ?
