Agricultural prices 1995/1996: minimum price for unginned cotton

Cotton: agricultural prices 1995/1996. It was proposed that for the 1995/1996 marketing year the minimum price of unginned cotton would be fixed at ECU 116.39 per 100 kg (no change from 1994/1995). The price was fixed in respect of the quality adopted for the target price and at the outset of the agricultural operation. The Regulation would apply from 01.09.1995. ?

The European Parliament rejected the request by its Committee on Agriculture for a 1% increase in agricultural prices for 1995/96. It approved the Commission proposal. ?
